PEFC chain of custody mechanism that traces and verifies the raw material through thirdparty audits.

Safe working conditions for foresters, manufacturers, and all other workers.



Recycling remains an important part of the solution.

The need for tree-based products is increasing, producing recyclable packaging and/or using recycled materials helps reduce the productive demand on forests.

When used as a supplement to PEFCcertified virgin fibres, recycled materials can help meet market demand for forest materials.

In this way, recycled materials and certified forest materials both **contribute** to a responsible packaging solution for your brand.







Include PEFC in your sourcing policy

Brands that choose PEFC-certified packaging act and communicate on their sustainability goals. Because PEFC certification is rigorous, impartial, and recognised, you can substantiate your sustainability statements related to responsible sourcing from the forests.

Brand owners know how important their packaging is. Not only does it keep the products inside safe and fresh, but the packaging itself is one of your most important brand assets. With an estimated 70% of purchasing decisions being made at the retail shelf, packaging converts shoppers to buyers.

By including PEFC in your procurement policies, and using the PEFC label on your certified packaging, you can communicate your sustainability actions to your customers.

You don't have to choose between PEFC and other certifications. In fact, inclusive procurement policies give you more supply flexibility and a greater chance of reaching your certified source target.



Protects from deforestation

How does choosing PEFC-certified product protect the forest? We need to use our forests. If we don't, the land will be used for other purposes, such as cattle ranches or soy plantations. Buying forest products, such as wood and paper, gives the forest value, it creates demand, and provides a financial incentive to keep a **forest** a **forest**.

Equally important, **forests are renewable**, and PEFC-certified forests are managed in a manner that ensures that they will be there for generations to come. Harvesting trees does not have a negative impact on the forests, as they will be replanted.

Supports reforestation

By increasing the demand on certified materials from sustainably managed forests, you are not only ensuring forest are kept forest you are also supporting sustainable managed forests growth.

Halting deforestation and increasing forest restoration is imperative for limiting global warming to 1.5°C. Forests represent one of the largest, most cost-effective climate solutions available today.
